FOR SERVICES BEGINNING JANUARY 1, 2021 OR LATER	FILING DEADLINE
REGISTRATIONS	Within 15 days of the start date, but no later than 10 days after actually exceeding \$5,000 in compensation and expenses
AMENDED REGISTRATIONS	Within 10 days of any change to the required information disclosed in the original Registration



LATE FEES

91 – 180 days	\$500 flat late fee	\$1,000 flat late fee
181 days and over	\$1,000 flat late fee	\$2,000 flat late fee

If a report is due on a weekend or a State holiday, the report must be received in the Commission's office on the first business day following the weekend or State holiday. The Commission does **not** consider the postmarked date as the date of receipt for lobbying filings.
