



## How to Navigate the Commission on Ethics and Lobbying in Government ('COELIG') Public Search Query ('PSQ')

The PSQ can be directly accessed from <https://reports.ethics.ny.gov/publicquery> or from the COELIG website at <https://ethics.ny.gov/>. From the home page, scroll to the 'Topics of Interest' section and select the 'Public Data' hyperlink. The Public Data page is also easily accessible by selecting 'View a Filing' from the 'About' and 'Lobbying' Main Navigation Menus.

The PSQ is divided into **three** primary categories:

1. **Global Search** – Provides information as to how Lobbyists, Clients, Beneficial Clients, Public Corporations are registered. Generally referred to and used as a 'registration finder'. Allows you to connect how organizations and individuals are affiliated to each other.
2. **Search by Disclosure Type** – The 'Search by Disclosure Type' section of the PSQ allows filers to search for specialized Filings that may not be required by every Filer. Reportable Business Relationship, Source of Funding, Disbursements of Public Monies Reports and Member Contributions to Coalitions can be found here.
3. **Search by Lobbying Focus** – If you want to know which organizations lobbied on a particular lobbying subject, or are interested in whose lobbying on State or Municipal Focuses such as Legislative bills, procurements, executive orders, etc.

### Global Search Features and Best Practices

As a best practice we often recommend users conduct a broad-based search and then refine their search results using search parameters.

1. Click the 'Global Search' tab
2. Select the 'Filer Type' by clicking on one of the applicable radio buttons. For best results, select either 'Lobbyist' or 'ALL' when beginning your search.

3. If you know the name of the Organization or Individual, you may enter the name in the **'Text Search Box'**. For best results when searching for an 'Organization' enter the main identifier of the name. *Example:* To search for 'Google, LLC,' enter Google in the search bar without punctuation.
4. To isolate search results to a specific **'Year'** or **'Level of Government'**:
  - Lobbyist and Public Corporation Statements of Registrations cover a two-year (biennial) period. Select the **'Year'** from the drop-down menu to isolate results for that specific biennial.
  - Select the **'Level of Government'** drop-down menu to isolate results for State Lobbying, Municipal Lobbying or Both (State and Municipal).

## Filer Library Features

To access the **Filer Library**, click on any of the hyperlink names (displayed in bold light blue font) in the search results. The Filer Library includes search results in the Principal Lobbyist, Individual Lobbyist(s), Co – Lobbyist(s)/ Sub – Lobbyist(s), Contractual Client and Beneficial Client column headings.

Once an individual or organization name has been selected, you will be directed to the selected Filer Library. The Filer Library contains all the Filings submitted by the Organization or on its behalf. In the case of an Individual Lobbyist, the Filer Library will contain every Filing where that specific Individual Lobbyist has been named on a Filing.

1. If the **'Organization'** name has been changed in anyway, click the FKA expanding/collapsing menu to view any applicable name changes. Expanding/collapsing menu items are denoted with the [+] plus signs.
2. To control the number of Filings displayed at once, select the **'Show Entries'** drop-down menu.
3. Every column can be sorted by **ascending/descending order** to allow users the most flexibility in deciding how to locate and sort search results.
4. To view a specific Filing, click any of the blue hyperlinks in the **'Type'** column.

### Search by Disclosure Type

---

The **'Search by Disclosure Type'** section of the PSQ allows filers to search for specialized Filings that may not be required by every Filer. Coalition Contributions reported by Lobbyist and Clients in their Bi-Monthlies and/or Client Semi-Annuals can also be searched here.

Below is a summary of the type of information contained in each of the following filings:

- **Reportable Business Relationship** – required by Lobbyists and Clients that pay or promise to pay a State Person through a formal or informal agreement.
- **Source of Funding** – Source of Funding disclosure is intended to provide the public with more information regarding the actual entities and individuals that support lobbying campaigns in New York State. Disclosure is required by Client Filers.
- **Disbursement of Public Monies** – required to be filed by Lobbyists who anticipate spending over \$5,000 on Public Monies valued at more than \$15,000. Public Monies are funds that have been designated for programs, grants, or discretionary funds, but which have not been allocated by law to specific recipients and are not part of a Governmental Procurement.
- **Coalition Contribution** – searches Lobbyist Bi-Monthlies and Client Semi-Annual reports for those Filers who contribute to Unstructured Coalitions.

### How to Search for State and Municipal Level Focuses

#### Legislative Bill Search Instructions

1. Click the **'Search by Lobbying Focus'** button.
2. Select **'State Activities'**
3. Click the **'Legislative Bills'** menu item.
4. Enter a **'keyword'** in the **'Search by Bill Number or Keyword, if known'** text search box.
5. Click **'View Results'**
6. To view the entire filing, click the **'View'** button in the **'Associated Filings'** column.
